**SUPPLEMENTAL CERTIFICATION OF PROFESSIONAL IN SUPPORT OF


along with the Series 1998 Bonds, collectively, the "Bonds"). One of the holders of the Bonds referred C.W. to the Debtor.

3. Paragraph 7 of the C.W. engagement letter attached as Exhibit A to the Debtor's application to retain C.W. indicates that C.W. may represent a potential purchaser or investor with respect to the assets sought to be marketed. It is not C.W.'s current intention to represent any potential investor or purchaser with respect to the assets and if C.W. seeks to do so it will file a supplemental disclosure with the Court. It is possible that C.W., by the nature of its business, will, as part of soliciting bids for the assets, solicit bids from, *inter alia*, entities with whom it has a prior business relationship.


