

Dear Judge Gambardella:

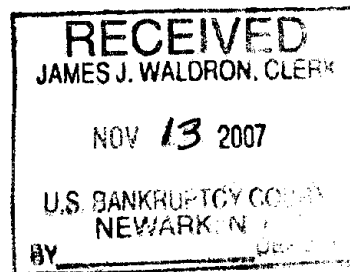
I represent the Township of River Vale, Bergen County, New Jersey. Our residents are served by the Debtor, Pascack Valley Hospital Association, Inc. I have been requested on behalf of the Township of River Vale to respectfully request Your Honor deny the Debtor's motion for an Order authorizing it to sell its Mobile Intensive Care Unit ("MICU").

The Township of River Vale strongly believes that if the MICU is sold as a separate asset pursuant to the requested Order, this action will eliminate the ability for any health care provider to purchase the remaining assets of the hospital and operate it as a functioning medical facility. The Township of River Vale further believes that the continued operation of this facility as a hospital is in the best interests of all of the surrounding communities. As a result, the Township of River Vale joins the Borough of Westwood and the Borough of Old Tappan in opposition to this Motion and respectfully requests that Your Honor deny the pending Motion, at least until such time as there has been a reasonable opportunity to exhaust efforts to sell the hospital as a whole to another health care provider.
