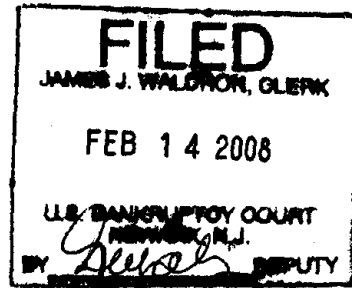


IT IS on this
