**VERIFIED SUPPLEMENT TO VERIFIED APPLICATION IN SUPPORT OF DEBTOR'S  
MOTION SEEKING THE ENTRY OF AN ORDER, PURSUANT TO 11 U.S.C. §§ 541 AND  
105(a), AND 28 U.S.C. § 1334(e), AUTHORIZING THE DEBTOR TO RETURN CERTAIN  
MONIES THAT ARE NOT PROPERTY OF THE DEBTOR'S ESTATE**

**TO: THE HONORABLE ROSEMARY GAMBARDELLA, U.S.B.J.**

Pascack Valley Hospital Association, Inc., the debtor and debtor-in-possession ("PVH") or the "Debtor"), by and through its attorneys, Sills Cummis & Gross P.C., submits this Verified Supplement (the "Supplement") to Verified Application (the "Verified Application") in support of the Debtor's motion (the "Motion") seeking the entry of an order, pursuant to sections 541 and 105(a) of chapter 11, Title 11 of the United States Code, and section 1334(e) of Title 28 of the United States Code, authorizing the Debtor to return certain monies (collectively, the "Monies") held by the Debtor that are not property of the Debtor's estate. In further support of the Motion, the Debtor respectfully represents as follows:

1. As set forth in detail in the Verified Application, by the Motion the Debtor seeks an order, pursuant to sections 541 and 105(a) of the Bankruptcy Code, and 28 U.S.C. § 1334(e), authorizing the Debtor to return the Monies to certain doctors (collectively, the “Doctors”) on the basis that the Monies are not property of the Debtor’s estate and are not subject to the *in rem* jurisdiction of the Court.

2. As further support that the Monies were provided by the Doctors to PVH to be deposited into the account of non-debtor and now defunct Pascack Radiation Therapy Management, LLC (“PRTMC”), and thus are not property of the Debtor’s estate, the Debtor submits the vouchers annexed hereto as Exhibit A. The vouchers reflect PVH’s receipt of the Monies, the name of each Doctor, the amount provided by each Doctor, and recordation as PRTMC funds.

3. The Debtor further submits Exhibit B hereto, which is a schedule generated by the Debtor reflecting that the Monies were internally recorded by PVH on 12/26/06 when they were received and deposited into PVH’s bank account and noted as PRTMC funds.

4. Based on the foregoing, and the facts and law set forth in the Verified Application, and the Exhibits thereto, the Monies should be returned to the Doctors and the Debtor submits that the Court’s issuance of an order authorizing the Debtor to return the Monies to the Doctors is necessary and appropriate to carrying out the provisions of the Bankruptcy Code, pursuant to 11 U.S.C. §§ 105(a) and 541.

**WHEREFORE**, the Debtor respectfully requests the entry of an Order granting the relief requested in the Verified Application and herein, and granting such other and further relief as is just and proper.
